

RESOLUTION NO. 2017 - R-009

**A RESOLUTION TO APPROVE A CONDITIONAL USE PERMIT FOR INNOVATIVE LIVESTOCK SERVICES, INC. FOR THE CONSTRUCTION AND OPERATION OF A COMMERCIAL/INDUSTRIAL STORAGE SITE LIMITED TO THE STORAGE OF WIND GENERATION PARTS – TUBES AND BLADES UPON THE REAL PROPERTY LEGALLY DESCRIBED AS PART OF THE SE ¼ OF SECTION 14, NW ¼, W ½ OF SW ¼, NE ¼, & SE ¼ OF SECTION 24, TOWNSHIP 21 SOUTH, RANGE 16 WEST, SECTION 19, TOWNSHIP 21 SOUTH, RANGE 15 WEST, PAWNEE COUNTY, KANSAS.**

**WHEREAS**, on June 5, 2017, the Pawnee County Joint Planning Commission held a public hearing, following published notification, to consider the conditional use permit application submitted by Innovative Livestock Services, Inc., for the purpose of construction and operation of a commercial/industrial storage site upon the real property legally described as part of the SE ¼ of Section 14, NW ¼, W ½ of SW ¼, NE ¼, & SE ¼ of Section 24, Township 21 South, Range 16 West, Section 19, Township 21 South, Range 15 West, Pawnee County, KS.

**WHEREAS**, on June 5, 2017, the Pawnee County Joint Planning Commission has, by a unanimous vote of all its members present, recommended that the Governing Body of Pawnee County, Kansas approve the application for the conditional use permit submitted by Innovative Livestock Services, Inc.

**WHEREAS**, the statutory 14 day protest period has lapsed and no written protest to the proposed conditional use permit and the development plans has been filed with the County Clerk;

**AND WHEREAS**, on June 12, 2017, the Board of County Commissioners received a written summary of the public hearing and the recommendation of the Pawnee County Joint Planning Commission to approve the application for a conditional use permit.


